- vii) Appointment will be subject to CAA's medical fitness standards.

- viii) Government servants / employees of autonomous bodies / corporations will be required to submit **NOC from current employer before interview.**
- ix) Incorrect information and any attempt to influence the selection process will be considered as a definite disqualification for current as well as future recruitment in CAA, even if the candidate is otherwise qualified.
- x) In case, any educational documents or any other document provided by the applicants is found incorrect / fake / bogus at any stage, the services of selected candidate will be terminated immediately and he / she will not be considered for any job in future in CAA.
